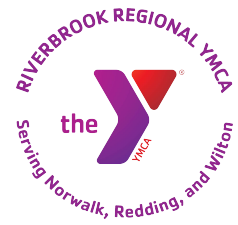

Membership Dues:

The current 2025 Membership Dues are outlined below. Monthly draft memberships will be pulled via credit/debit card or electronic funds transfer on either the 1st or 15th of the month. If my monthly draft payment is declined, the Y will attempt to draft throughout the month to complete payment.

Continuation of Membership:

I understand and agree that if I join as a membership type with a monthly draft (either through credit card or electronic funds transfer), it will be charged as a continuous membership plan. This membership will remain in effect for as long as I maintain current payment.

I understand and agree that if I join as a membership type with an annual renewal, my membership will be active for one year from the date of annual payment. I will be sent written and/or electronic notice of my option for renewal. If renewal is not initiated, my membership will be terminated by the Y.

Cancellation of Membership:

I understand and agree that if I wish to terminate my continuous membership plan, I must complete a cancellation request via one of the Y's designated membership termination channels. The termination channels are:

- online termination effective immediately through your Y account
 - an email to membership@riverbrookymca.org
- the completion and submission to the Y of an online or paper copy of our cancellation form

I understand that cancellation can be effective immediately if processed through my Y account. I understand that cancellation done through email or the completion of the online or paper form may take 3 days to process and become effective. Cancellation can be effective immediately through my Y account.

I also understand and agree that if I terminate my membership after my monthly draft, I will not be refunded a pro-rate for that month. I will not be subject to additional draft's post successful cancellation.

I understand that I will be notified of my successful termination.

Unsuccessful Drafts:

I understand it is my responsibility to notify the Riverbrook Regional YMCA of any change in address, bank account information (if utilizing bank draft for payment of dues) credit card information, new number or expiration date (if utilizing credit card for payment of dues). I authorize the Riverbrook Regional YMCA to update my banking and credit card information, in my account, when necessary.

Future Rate Increases or Changes:

I understand and agree that the Riverbrook Regional YMCA reserves the right to change fees with 30 days' notice and I will have the option to cancel my membership or not renew.

I understand that my membership type may be changed by the Y due to membership type age requirements. If I maintain an active membership without cancellation and I age into a different category, I understand and agree to be moved into the next age category and accept the price difference.

Membership and Programs:

I understand that I must maintain a membership through program completion to retain the "member pricing" on said program. If I choose to cancel before the program completion, I will owe the difference between the member and non-member price for said program.

Membership Terms:

I understand that all memberships are non-refundable and non-transferable.
